CEASE AND DESIST ORDER

The Alabama Securities Commission ("Commission"), having the power to administer and provide for the enforcement of all provisions of Title 8, Chapter 6, Code of Alabama 1975, the Alabama Securities Act, upon due consideration of the subject matter hereof, and having confirmed information of the offer and or sale of securities into, within, or from the State of Alabama, has determined as follows:

RESPONDENTS

1. ATTRACTIONS PLUS ("RESPONDENT ATTRACTIONS"), is represented to be a travel agency with a business address of 5439 Beaumont Center Boulevard, Suite 104, Tampa, FL 33634.
2. J. ERIC WADE ("RESPONDENT WADE"), is represented to be an agent of RESPONDENT ATTRACTIONS with a business addresses of P. O. Box 867, Magnolia Springs, AL 36555, 8105 County Road 32, Fairhope, AL 36532, and P. O. Box 1157, Fairhope, AL 36533.

STATEMENT OF FACTS

3. The Commission is in receipt of information that, RESPONDENT WADE, acting as an agent of RESPONDENT ATTRACTIONS, engaged in the offer and/or sale of investment contracts involving shares of RESPONDENT ATTRACTIONS to Alabama residents, that were neither registered nor exempt from registration in the state of Alabama.

4. Review of the files of the Commission, disclosed no record of registration for RESPONDENTS WADE, or ATTRACTIONS as a securities dealer or agent in the state of Alabama.

5. Review of the files of the Commission, disclosed no record of registration, nor exemption from registration, of the securities of RESPONDENT ATTRACTIONS.

CONCLUSIONS OF LAW

6. RESPONDENTS WADE, and ATTRACTIONS, are not registered as securities dealers or agents in the State of Alabama.

7. Transacting business in the State of Alabama as a securities dealer or agent while unregistered is a violation of § 8-6-3(a), Code of Alabama, 1975.

8. The securities of RESPONDENT ATTRACTIONS offered by RESPONDENT WADE, as set forth in paragraph 3, above, are not registered, nor exempt from registration in the state of Alabama.

9. The sale of unregistered, non-exempt securities into, within, or from the state of Alabama is a violation of § 8-6-4, Code of Alabama, 1975.

This order does not prevent the Alabama Securities Commission from seeking such other civil or criminal remedies as are available to it under the Alabama Securities Act.

This order is appropriate in the public interest for the protection of investors and consistent with the purpose of the Alabama Securities Act.

ACCORDINGLY, IT IS HEREBY ORDERED that, RESPONDENTS
ATTRACTIONS PLUS, and J. ERIC WADE, immediately **CEASE AND DESIST**
from further offers or sales of any security into, within or from the State of
Alabama.
