CEASE AND DESIST ORDER

The Alabama Securities Commission ("Commission"), having the power to administer and provide for the enforcement of all provisions of Title 8, Chapter 6, Code of Alabama 1975, the Alabama Securities Act ("Act"), upon due consideration of the subject matter hereof, and having confirmed information of the offers for sale and/or sale of securities, into, within or from the state of Alabama, has determined as follows:

RESPONDENTS

1. CONSULTING DYNAMICS, INC. ("CONSULTING") is a Nevada corporation, with California business addresses of 1339 E. Katella Avenue, Suite 299, Orange, California 92867, and 780 N. Euclid Street, Anaheim, California 92801.
2. ADVANCE BODY IMAGING, L.P. ("ADVANCE") is a California company, with a business address of 1339 E. Katella Avenue, Suite 299, Orange, California 92867.
3. STANLEY JOHNSON ("S. JOHNSON") is the Director, Treasurer, Vice President, and Chief Operations Officer of CONSULTING, with a business address of 1339 E. Katella Avenue, Suite 299, Orange, California 92867.

4. EASTER JOHNSON ("E. JOHNSON") is the Director, President and Secretary of CONSULTING, with a business address of 1339 E. Katella Avenue, Suite 299, Orange, California 92867.

5. JOHN LEAL ("LEAL") is the Director of Operations of ADVANCE, with a business address of 1339 E. Katella Avenue, Suite 299, Orange, California 92867.

6. JUNE VENTZOS ("VENTZOS") is the Director of Marketing of ADVANCE, with a business address of 1339 E. Katella Avenue, Suite 299, Orange, California 92867.

7. ALEXANDER WILSON ("WILSON") is the Manager of Operations of ADVANCE, with a business address of 1339 E. Katella Avenue, Suite 299, Orange, California 92867.

8. NATALIE ROMO ("ROMO") is an Investment Representative of ADVANCE, with a business address of 1339 E. Katella Avenue, Suite 299, Orange, California 92867.

STATEMENT OF FACTS

9. Information made available to the COMMISSION indicates ROMO, acting as an agent of ADVANCE, made general solicitations ("cold calls") to Alabama residents, during which ROMO offered investments in the ADVANCE limited offering issued by CONSULTING

10. ROMO made the initial contact and solicitation of the investor. When the investor expressed interest in ADVANCE, he was transferred to S. JOHNSON who completed the sale of the investment.

11. Information made available to the COMMISSION indicates S. JOHNSON offered and sold unregistered securities, in the form of interests in the ADVANCE limited partnership to investors residing in the state of Alabama.

12. A review of the U.S. Securities and Exchange Commission ("U.S. SEC") EDGAR website disclosed a Reg. D 506 filing for the ADVANCE offering, submitted by CONSULTING, and received by the U.S. SEC on July 6, 2004. This filing provides specific exemptions to registration for companies under the Securities Act of 1933.

13. A review of the files of the COMMISSION'S Registration Division disclosed a Reg. D 506 notice filing for the ADVANCE offering issued by CONSULTING, and received by the COMMISSION on February 15, 2005.

14. The general solicitations made by CONSULTING and ADVANCE are in violation of the United States Securities and Exchange Regulation 230.502(c), regarding Limitation on Manner of Offering. The exemption for registration concerning Reg. D 506 (Limited Offering) is conditional to the issuer abiding by rules against general solicitation. The violation committed by the agent of CONSULTING and ADVANCE voids any registration exemption claimed by CONSULTING concerning the ADVANCE offering issued by the company.

15. LEAL, VENTZOS, and WILSON are listed in company materials as the Officers and Directors of ADVANCE. The Alabama investor relied on the management and expertise of LEAL, VENTZOS, and WILSON to return a profit on the investment. LEAL, VENTZOS, and WILSON, along with their skills and experience, are predominantly listed in documentation provided to the investor.

16. A review of the files of the Alabama Securities Commission Registration Division disclosed no record of registration, or exemption from registration for CONSULTING or ADVANCE as a Securities Agent or Dealer in the state of Alabama.

17. A review of the files of the Alabama Securities Commission Registration Division disclosed no record of registration, or exemption from registration for S. JOHNSON, E. JOHNSON, LEAL, VENTZOS, WILSON, or ROMO as a Securities Agent or Dealer in the state of Alabama.

18. Information made available to the COMMISSION indicates investment funds raised by the ADVANCE offering were used by S. JOHNSON to purchase ownership interests from Randy Morton, in a series of separate limited offerings titled LIFELINE IMAGING, et al., and ADVANCED IMAGING, et al.

19. On February 2, 2005, the COMMISSION issued a Cease & Desist Order to Lifeline Imaging, et al. and General Partner Randy Morton. The order pertained to the offer and sell of unregistered securities by unregistered agents. Like the ADVANCED offering, the LIFELINE offerings filed for a registration exemption under Regulation D Rule 506, but also voided the registration exemption through the use of general solicitations.

20. S. JOHNSON is a former employee of Randy Morton. Evidence available to the COMMISSION indicates S. JOHNSON offered and sold investments, through the use of general solicitations, in the various Lifeline and Advanced Imaging offerings.

CONCLUSIONS OF LAW

21. Neither CONSULTING, ADVANCE, S. JOHNSON, E. JOHNSON, LEAL, VENTZOS, WILSON, nor ROMO, are registered, or exempt from registration as a Dealer or Agent in the state of Alabama. The sale of securities by an unregistered Dealer or Agent in the state of Alabama is a violation of Section 8-6-3(a), Code of Alabama 1975.

22. Due to the general solicitation made by the agent ADVANCE, the registration exemption for the offer of this particular security is void; therefore, the ADVANCE limited offering issued by CONSULTING is not registered, nor exempt from registration, in the state of Alabama. The sale of unregistered securities, in the state of Alabama is a violation of Section 8-6-4, Code of Alabama 1975.

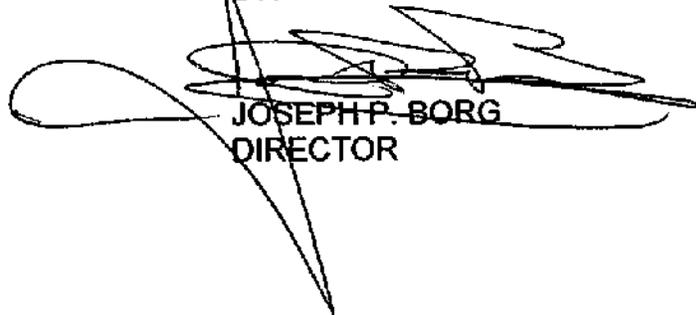
This Order does not prevent the Alabama Securities Commission from seeking such other civil or criminal remedies that are available to it under the Act.

This Order is appropriate in the public interest for the protection of investors and is consistent with the purposes of the Act.

ACCORDINGLY, IT IS HEREBY ORDERED that RESPONDENTS immediately **CEASE AND DESIST** from further offers or sales of any security into, within or from the state of Alabama.
