CEASE AND DESIST ORDER

The Alabama Securities Commission ("Commission"), having the power to administer and provide for the enforcement of all provisions of Title 8, Chapter 6, Code of Alabama 1975, the Alabama Securities Act, upon due consideration of the subject matter hereof, and having confirmed information of the offer and sale of securities into, within, or from the State of Alabama, has determined as follows:

RESPONDENTS

1. FIRST AMERICAP CORPORATION ("RESPONDENT FAC") is a Houston-based, Texas corporation with a business address of 2406 Mimosa, Houston, TX 77254.

2. CAPITAL RELATIONS GROUP, LLC ("RESPONDENT CRG") is a Houston-based, Texas limited liability company with a business address of 2406 Mimosa, Houston, TX 77254.

3. STEPHEN HARRISON THOMAS ("RESPONDENT S. THOMAS"), is a principal and agent of Respondent FAC with a business address of 2406 Mimosa, Houston, TX 77254.

4. ROBERT DOUGLAS WILLIAMS ("RESPONDENT WILLIAMS"), is a principal agent of Respondent FAC and Respondent CRG with a business address of 2406 Mimosa, Houston, TX 77254.

5. TIJI THOMAS ("RESPONDENT T. THOMAS"), is a principal and agent of Respondent FAC and Respondent CRG with a business address of 2406 Mimosa, Houston, TX 77254.

6. CYRUS INDUSTRIES, INC. (f/k/a ICON TRADING, INC.) ("RESPONDENT CII") is a Nevada corporation with a business address of 18915 Rocking Horse Lane, Huntington Beach, CA 92648-1573.

7. RAECE B. RICHARDSON ("RESPONDENT RICHARDSON"), is a principal and agent of Respondent CII with a business address of 1900 Avenue Of The Stars, #2700, Los Angeles, CA 90067-4508.

8. BYTEAUDIO.COM ("RESPONDENT BYT") is a Florida corporation with a business address of 1417 S. Powerline Road, Pompano Beach, FL 33069.

STATEMENT OF FACTS

9. The Commission is in receipt of information that RESPONDENTS S. THOMAS, WILLIAMS, T. THOMAS, RICHARDSON, FAC, CRG, CII AND BYT offered for sale in the State of Alabama stock in CYRUS INDUSTRIES, INC. (F/K/A ICON TRADING, INC.) and BYTEAUDIO.COM.

10. Review of the files of the Commission, disclosed no record of the registrations of RESPONDENTS S. THOMAS, WILLIAMS, T. THOMAS, RICHARDSON, FAC, CRG, CII or BYT.

11. Review of the files of the Commission, disclosed no record of registration, nor exemption from registration, of the securities of RESPONDENTS CII or BYT.

CONCLUSIONS OF LAW

12. RESPONDENTS S. THOMAS, WILLIAMS, T. THOMAS, RICHARDSON, FAC, CRG, CII and BYT are not registered as securities dealers or agents in the state of Alabama.

13. Transacting business in the State of Alabama as a securities dealer or agent while unregistered is a violation of § 8-6-3(a), Code of Alabama, 1975.

14. The securities of RESPONDENTS CYRUS INDUSTRIES, INC. (F/K/A ICON TRADING, INC.) and BYTEAUDIO.COM, sold by RESPONDENTS S. THOMAS, WILLIAMS, T. THOMAS, and RICHARDSON, as set forth in paragraph 11, above, are not registered, nor exempt from registration in the state of Alabama.

15. The sale of unregistered, non-exempt securities into, within, or from the state of Alabama is a violation of § 8-6-4, Code of Alabama, 1975.

16. RESPONDENTS FAC and CRG, by allowing RESPONDENTS S. THOMAS, WILLIAMS, T. THOMAS and RICHARDSON to sell the unregistered, non-exempt securities of RESPONDENTS CYRUS INDUSTRIES, INC. (F/K/A ICON TRADING, INC.) and BYTEAUDIO.COM failed to adequately supervise an associated person.

17. Failure to adequately supervise an associated person is a violation of Commission Rule 830-X-3-.13.

This Order does not prevent the Alabama Securities Commission from seeking such other civil or criminal remedies that are available to it under the Alabama Securities Act.

This Order is appropriate in the public interest for the protection of investors and consistent with the purpose of the Alabama Securities Act.

ACCORDINGLY, IT IS HEREBY ORDERED that, RESPONDENTS S. THOMAS, WILLIAMS, T. THOMAS, RICHARDSON, FAC, CRG, CII, and BYT, immediately CEASE AND DESIST from further offers or sales of any security into, within, or from the State of Alabama.
