CEASE AND DESIST ORDER

The Alabama Securities Commission ("Commission"), having the power to administer and provide for the enforcement of all provisions of Title 8, Chapter 6, Code of Alabama 1975, the Alabama Securities Act ("Act"), upon due consideration of the subject matter hereof, and having confirmed information of the offers for sale and/or sale of securities, into, within or from the state of Alabama, has determined as follows:

RESPONDENTS

1. BIOTELLIGENT, INC. ("BIOTELLIGENT") is a California company, with a business address of 85 Enterprise, Suite 400, Aliso Viejo, California, 92656.

2. HENY AYATI ("AYATI") is an Investor Relations representative with BIOTELLIGENT, with a business address of 85 Enterprise, Suite 400, Aliso Viejo, California, 92656.

STATEMENT OF FACTS

3. Information made available to the Commission indicates that in February of 2005, AYATI offered an investment of common stock in BIOTELLIGENT, through a private placement offering, to an investor residing in Alabama.

4. A review of the files of the Alabama Securities Commission Registration Division disclosed no record of registration, nor exemption from registration, for AYATI as a Securities Agent or Dealer in the state of Alabama.

5. A review of the files of the Alabama Securities Commission Registration Division disclosed no record of registration, nor exemption from registration, for BIOTELLIGENT as a Securities Agent or Dealer in the state of Alabama.

6. Information made available to the Commission indicates that AYATI had a previous relationship with the Alabama resident. The resident had been previously solicited by AYATI, and subsequently invested in a separate company named Woman's Wallstreet, Inc. AYATI is a representative of the Investor Relations department of both BIOTELLIGENT and Woman's Wallstreet. Both companies use the same business address.

CONCLUSIONS OF LAW

7. Neither AYATI or BIOTELLIGENT are registered, nor exempt from registration as a Dealer or Agent in the state of Alabama. The sale of securities by an unregistered Dealer or Agent in the state of Alabama is a violation of Section 8-6-3(a), Code of Alabama 1975.

8. The private placement memorandum issued by BIOTELLIGENT is not registered, nor exempt from registration, in the state of Alabama. The sale of unregistered securities, in the state of Alabama is a violation of Section 8-6-4, Code of Alabama 1975.

This Order does not prevent the Alabama Securities Commission from seeking such other civil or criminal remedies that are available to it under the Act.

This Order is appropriate in the public interest for the protection of investors and is consistent with the purposes of the Act.

ACCORDINGLY, IT IS HEREBY ORDERED that RESPONDENTS immediately **CEASE AND DESIST** from further offers or sales of any security into, within or from the state of Alabama.
