CEASE AND DESIST ORDER

The Alabama Securities Commission ("Commission"), having the power to administer and provide for the enforcement of all provisions of Title 8, Chapter 6, Code of Alabama 1975, the Alabama Securities Act ("Act"), upon due consideration of the subject matter hereof, and having confirmed information of the offers for sale and/or sale of securities, into, within or from the state of Alabama, has determined as follows:

RESPONDENTS

1.e NEW WORLD VENTURES INVESTMENT INC ("NWVII") is an unregistered investmente firm, with a business address of 24 de Castro Street, Wickhams Cay Road Town, Tortola, British Virgin Islands.

2.e BLUE DOG/BLUE DOG CASINOS, ("BLUE DOG") is an unregistered investment firm,e with a business address of Office Unit #2, Post Office Box W1409, Wood's Center, St. John's Antigua, West Indies.

3.e CARIBBEAN INTERNET INVESTMENT LTD, ("CII") is an unregistered investment firm,e with a business address of Post Office Box W1227, Wood's Center, St. John's Antigua, West Indies.

4.e LENNOX PATON, ("PATON") is an agent for NWVII, with a business address of Forte Nassau Centre, Marlborough Street, Post Office Box N-4875, Nassau, Bahamas. At all times relevant to the violations set forth herein, PATON acted as an agent of NWVII.

5. MORTON PIASETSKI, ("PIASETSKI") is an agent for NWVII, with a business address of Fort Nassau Centre, Marlborough Street, Post Office Box N-4875, Nassau, Bahamas. At all times relevant to the violations set forth herein, PATON acted as an agent of NWVII.

STATEMENT OF FACTS

6. The Commission is in receipt of information that PATON & PIASETSKI engaged in the offer and/or sale of securities, to wit: shares of NWVII, BLUE DOG, and CII, to an Alabama resident, that were neither registered nor exempt from registration in the State of Alabama.

7. A review of the files of the Commission disclosed no record of registration of PATON, PIASETSKI, or NWVII, BLUE DOG, and CII as securities agents/dealers in the state of Alabama.

8. A review of the files of the Commission disclosed no record of registration, or exemption from registration, of the securities of NWVII, BLUE DOG, and CII.

CONCLUSIONS OF LAW

9. NWVII, BLUE DOG, and CII are not registered as a securities dealer in the state of Alabama. Transacting business in the State of Alabama as a securities dealer while unregistered is a violation of § 8-6-3(a), Code of Alabama, 1975.

10. PATON & PIASETSKI are not registered as a securities agent in the state of Alabama. Transacting business in the State of Alabama as a securities agent while unregistered is a violation of § 8-6-3(a), Code of Alabama, 1975.

11. The securities of NWVII, BLUE DOG, and CII, being sold by PATON & PIASETSKI as set forth in paragraph 3 above, are not registered, nor exempt from registration in the state of Alabama. The sale of unregistered, non-exempt securities into, within, or from the state of Alabama is a violation of § 8-6-4, Code of Alabama, 1975.

This Order does not prevent the Alabama Securities Commission from seeking such other civil or criminal remedies that are available to it under the Alabama Securities Act.

This Order is appropriate in the public interest for the protection of investors and consistent with the purpose of the Alabama Securities Act.


