**ORDER TO VACATE AS TO MORTON PIASETSKI
ONLY**

The Alabama Securities Commission ("Commission"), having the power to administer and provide for the enforcement of all provisions of Title 8, Chapter 6, Code of Alabama 1975, the Alabama Securities Act, upon due consideration of the subject matter hereof, has determined as follows:

RESPONDENT

1. As represented in Cease and Desist Order No. CD-2006-0002, MORTON PIASETSKI (PIASETSKI) was an agent of New World Ventures Investment, Inc. with a business address of Fort Nassau Centre, Malborough Street, P.O. Box N4875, Nassau Bahamas. **Note: On December 11, 2008, and again on January 16, 2009, the Commission received information that PIASETSKI was employed by Valdy Administration, Inc., with one of its clients being Dinber Management, Inc. In this capacity, PIASETSKI performed only ministerial duties for New World Ventures, Inc.**

STATEMENT OF FACTS

2. The Commission received from an Alabama investor a stock certificate issued by New World Ventures Investment, Inc. that was signed by PIASETSKI. In particular, the signature on the certificate read "Dinber Management, Inc., By: Morton Piasetski, Its: President."

3. A research of all indices showed that New World Ventures Investments, Inc., PIASETSKI and all of the Respondents in Administrative Order No. CD-2006-0002 were not registered to sell securities in Alabama and the stock was not registered as required by the Alabama Securities Act.

4. On January 18, 2006, the Commission issued a Cease and Desist Order and Notice of Right to a Hearing to RESPONDENTS, including PIASETSKI. The Commission had information that PIASETSKI's business address was Fort Nassau Centre, Malborough Street, P.O. Box N4875, Nassau Bahamas. The Cease and Desist Order became a Final Order of the Commission on July 9, 2007.

5. On December 11, 2008, PIASETSKI informed the Commission that he was never associated with the above address and did not receive service of the Cease and Desist Order, Administrative Order No. CD-2006-002. Accordingly, he asked and the Commission agreed to reopen the case as it relates to PIASETSKI.

5. Additionally, on December 11, 2008, the Commission received information from PIASETSKI by affidavit that PIASETSKI, through his employer Valdy Administration, Inc. performed ministerial duties for New World Ventures Investment, Inc. and has no knowledge as to the issuance of the certificate. This information was confirmed during the informal hearing conducted by telephone on January 16, 2009.


