Selma-Dallas County Youth Learn Personal Finance Options, Enjoy Capitol Visit

Montgomery, AL (Mar. 19, 2007) Thirty high school juniors and seniors, representing Youth Leadership Selma-Dallas County from seven area schools, recently visited the Alabama Securities Commission (ASC) in Montgomery to gain valuable insight about personal finance and money management.

The ASC, in partnership with Leadership Selma-Dallas County, the Alabama Council on Economic Education (ACEE) and the Alabama Cooperative Extension Service, hosted the students as part of the FLAIR (Financial Literacy And Individual Responsibility) program. After a guided tour of the Alabama State Capitol, students learned about the principles of saving/budgeting, wise use of credit, various investment instruments and fraud prevention. Rounding out the day's activities was a thought-provoking film exploring how teens can achieve personal financial success as they prepare to graduate from school and enter the work force.

Participating with students during the event were Carolyn Powell, Outreach Coordinator for Congressman Artur Davis' office and Terry Griffin, Curriculum Consultant for ACEE.
