Alabama Securities Commission Appoints Amanda Senn Director

Montgomery, Alabama (May 30, 2023) –The Alabama Securities Commission (ASC) appointed Amanda Senn Director. Senn has been employed at the Commission since 2008. In her former role as Chief Deputy Director, Senn was responsible for supervising the activities of the Commission in regulating the securities industry, protecting investors, and promoting stability in Alabama financial markets. She advised the Commission on securities-related matters, investigating, and prosecuting fraudulent actions surrounding the sales of securities throughout the state of Alabama, and coordinating and litigating numerous multi-jurisdictional administrative, civil, and criminal matters. Senn also coordinates legislative liaison for the Commission. In that capacity, she advocates for investor protections and market integrity in Alabama.

She is a frequent speaker on Alabama's securities laws and Elder Justice, an instructor in a securities litigation course offered through NASAA, and has testified before the United State House of Representatives Committee on Financial Services Subcommittee on National Security, International Development and Monetary Policy on fraud and elder exploitation. Amanda is a member of the American Inns of Court, serves as Vice-President of the Montgomery County Bar Association, serves on the board of the Montgomery Volunteer Lawyer Program, and is immediate Past President of the Alabama Association of Regulatory Boards (AARB).
