ORDER OF DENIAL

The Alabama Securities Commission ("Commission"), having the authority to administer and provide for the enforcement of all provisions of Title 8, Chapter 6, Code of Alabama 1975, the Alabama Securities Act ("Act"), upon due consideration of the subject matter hereof, has determined as follows:

RESPONDENT

1. JUSTICE MANAGEMENT TEAM ("JMT"), CRD#149546, is a South Carolina limited liability company, with a business address of 10 Clemson Street, Charleston, SC 29403. Records maintained by the Alabama Securities Commission and Financial Industry Regulatory Authority ("FINRA") reflect that JMT has never been registered in the State of Alabama as an investment adviser.

2. JOHN CHARLES JUSTICE (JUSTICE), CRD#5386313, is the owner, control person and portfolio manager of JMT, with a business address of 10 Clemson Street, Charleston, SC 29403.

STATEMENT OF FACTS

3. On March 9, 2009, JMT applied electronically for registration via IARD as an investment adviser in the State of Alabama.

4. On March 18, 2009, the Commission staff issued a deficiency letter to JMT, which enumerated several deficiencies in the registration application. The application further reflected that the Investment Adviser was not registered in their home state.

5. On June 11, 2009, the Commission staff issued an intend to deny letter to JUSTICE on behalf of JMT via certified mail along with the deficiency letter dated March 18, 2009. There was no delivery receipt returned.

6. On June 30, 2009, the Commission staff issued an intend to deny letter to JUSTICE on behalf of JMT via certified mail along with the deficiency letter dated March 18, 2009. According to the delivery receipt, the records reflect that the letter was delivered on July 7, 2009.

7. On October 27, 2009, the Commission staff issued an intend to deny letter to JUSTICE on behalf of JMT, via email, along with the deficiency letter dated March 18, 2009.

8. On January 14, 2010, the Commission staff telephoned the office of Justice Management Team and left a message advising that Mr. John Justice must contact the Alabama Securities Commission's office to discuss the registration application. The Commission staff has made several calls to the contact telephone number listed on the Web IARD system and, as of this date, Mr. Justice has not returned any of the phone calls.

9. On January 14, 2010, the Commission staff spoke with a member of South Carolina Securities and learned that JUSTICE paid registration application fees but has not completed the application for Investment Advisor registration in its home state of South Carolina.

CONCLUSIONS OF LAW

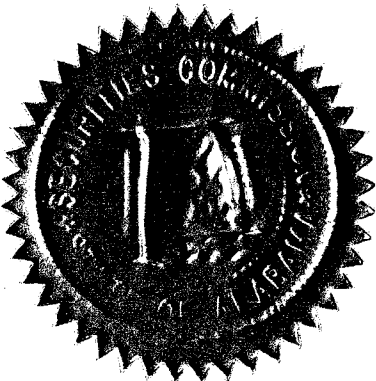
10. Pursuant to the provisions of Section 8-6-3(j)(1), Code of Alabama 1975, the Commission may suspend, revoke, deny, censor or bar any applicant or registrant or any officer,

director, partner, or person occupying a similar status or performing similar functions if the Commission finds that the Order is in the public interest and the applicant or registrant has filed an application for registration under this Section which incomplete in any material respect. JUSTICE has failed to file a complete application for registration as an investment advisor on behalf of JMT.

This Order is appropriate in the public interest for the protection of investors and is consistent with the purposes of the Act.

ACCORDINGLY, IT IS HEREBY ORDERED that the application for investment advisor registration in the State of Alabama filed by Justice Management Team is hereby **DENIED**.
